- The Managing Director, APSFTVTDC, Vijayawada shall undertake this activity without any other expectations which will be a burden to the state exchequer.
- The Managing Director, Andhra Pradesh State Film, Television & Theatre Development Corporation (APSFTVTDC) Vijayawada shall take further necessary action to build a data bank of artists/technicians etc., of Film, TV & Theater in the State by collecting data and to issue ID cards at his level keeping in view that no burden/ responsibility lies with the Government in this matter.
